Brown County Presbyterian Fellowship Annual Report for 2020 Rev. Dr. Scott D. Seay, Pastor

This year's annual report from your pastor will be just a little bit different because 2020 was anything but a normal year.

The year began typical enough: weekly worship and Bible study, regular fellowship, and dedicated service to the community. All seemed quite normal. But by mid-March reports of the coronavirus pandemic were apocalyptic, and the church entered into a nearly complete shut-down. We settled into a pattern of online worship, meetings by videoconference, and other socially isolated patterns of being church. It was very difficult for everyone. It pained us all not to be together for our typical Easter worship especially. We were anxious about not knowing when things might return to "normal."

By early June, paralyzing panic about the pandemic had begun to subside as we began to understand more about the coronavirus. In-person worship resumed on June 7, first in Fellowship Hall and later in the sanctuary, and we followed CDC-recommended safety protocols. Many continued to worship privately at home. A small group—something akin to an early Christian "house church"—worshipped together weekly. All followed the same worship service. This pattern continued more-or-less uninterrupted for the remainder of the year. Each has found ways to be faithful.

Weekly Bible study, too, was moved online as many of us learned new skills in videoconferencing. A small group of ten or so has completed a detailed study of Hebrews, and currently is working its way through Romans. God's Grace, too, has adjusted to the realities of the pandemic world. Its annual On the Road Again event was scaled down considerably, but still made a tremendous impact on the schoolchildren of Brown County and their families. Partnering with other county agencies, God's Grace has participated in periodic "pop-up pantries" to provide food and clothing to the vulnerable in our community. Especially significant is the ministry of providing almost 500 new winter coats for those in need.

You have the budget reports from Jane Gore, our treasurer. The pandemic upheaval has had virtually no impact on your faithfulness in financial giving. In fact, in the last six months or so, Session repeatedly has stepped up the church's contributions in our community: the Presbytery of Ohio Valley, Bethany Christian Services, Gleaner's Food Bank, and other local helping agencies. The need is greater than ever, and you should be proud that nearly 40% of the church's annual budget goes to compassionate service, concrete expressions of the Gospel.

As if the pandemic were not enough, in 2020 our nation faced a number of troublesome issues: a summer of protest over racial injustice, growing economic insecurity for some, a contentious election year, and as the new year dawned, political unrest in the capitol. More than once I have found myself wondering, "What is God trying to teach us here?" I believe it is this: faithful people always put their ultimate hope and trust in God; work for peace and

reconciliation; and show kindness toward and depend on one another.

I wish that I could predict when things will return to "normal." The widening availability of effective vaccines will no doubt help. You can be assured that, as soon as it medically advisable, we will resume our face-to-face ministries together. Yet, it is also clear that we will be a more nimble church, able to maintain connections and do ministry even when we can't be together. God is teaching us more than we now realize.

Until that day, let me urge us all to live in ways that Paul describes to the Roman Christians: "Hate what is evil; cling to what is good. Be devoted to one another in love. Honor one another above yourselves...Be joyful in hope, patient in affliction, faithful in prayer...Do not repay anyone evil for evil...If it is possible, as far as it depends on you, live at peace with everyone...Do not be overcome by evil, but overcome evil with good" (Romans 12:9-21).
